

END-USER LICENSE AGREEMENT FOR 'MOCHABLEND' AND 'MOCHABLEND EXPORTER'

IMPORTANT - PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: 'GOOD SPIRIT GRAPHICS' End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and 'GOOD SPIRIT GRAPHICS' for the 'GOOD SPIRIT GRAPHICS' software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation. ("SOFTWARE PRODUCT") By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and 'GOOD SPIRIT GRAPHICS', (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

1. GRANT OF LICENSE.

The SOFTWARE PRODUCT is licensed as follows:

(a) Installation and Use.

'GOOD SPIRIT GRAPHICS' grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed [e.g., Windows XP, Windows Vista, Windows 7, Windows 8, Apple operating systems, and Linux]. Each purchase of the SOFTWARE PRODUCT allows you to install it on up to 3 of your computers. If you install it on more than 3 of your computers, you are required to purchase additional copies.

(b) Backup Copies.

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the SOFTWARE PRODUCT.

(b) Distribution.

You may not distribute registered copies of the SOFTWARE PRODUCT to third parties. Evaluation versions available for download from 'GOOD SPIRIT GRAPHICS's websites may be freely distributed.

3. TERMINATION

Without prejudice to any other rights, 'GOOD SPIRIT GRAPHICS' may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.
